

THANKSGIVING - NOBILITY IN GOVERNMENT - TALMUD MEDIA VS. FARMERS

"Thus saith the Lord, Learn not the way of the heathen, and be not dismayed at the signs of heaven; for the heathen are dismayed at them." (Jeremiah 10:2)

ARE WE THANKFUL? Thanksgiving is one of the few declared national holidays that are of Christian origin with no apparent pagan insinuations. Fall is the time of harvest: an important occasion for farmers and those who live off the land. It was especially important for our early American forefathers whose survival through the coming winter depended upon a good harvest in the Fall. Of course, the Fall harvest was totally dependent upon God blessing them with a good growing season during the Summer, and upon getting the harvest in before bad weather set in.

Plymouth Colony's first few winters were extremely hard on them. Their closeness to nature's elements gave them a much better understanding and appreciation of man's dependence upon God's blessings of harvest. Today, over 90% of our people live in cities, or away from the farm, and don't share in that closeness with nature, and nature's God. However, Plymouth Colony's struggle for survival kept them keenly aware of such things.

They were blessed with a bountiful harvest in 1623, and so on Thursday, November 29th, of that year, three years after Mayflower's landing, Governor William Bradford declared a convocation:

TO ALL YE PILGRIMS

Inasmuch as the great Father has given us this year an abundant harvest of Indian corn, wheat, beans, squashes, and garden vegetables, and has made the forests to abound with game and the sea with fish and clams, and inasmuch as He has protected us from the ravages of the savages, has spared us

from pestilence and disease, has granted us freedom to worship God according to the dictates of our own conscience; now, I, your magistrate, do proclaim that all ye Pilgrims, with your wives and little ones, do gather at ye meeting house, on ye hill, between the hours of 9 and 12 in the day time, on Thursday, November ye 29th of the year of our Lord one thousand six hundred and twenty-three, and the third year since ye Pilgrims landed on ye Pilgrim Rock, there to listen to ye pastor, and render thanksgiving to ye Almighty God for all His blessings.

Later, on Thursday, November 26, 1789, President George Washington declared "a day of public thanksgiving and prayer, to be observed by acknowledging with grateful hearts the many and signal favors of Almighty God, especially by affording them an opportunity peacefully to establish a form of government for their safety and happiness."

Then, in 1863, President Lincoln proclaimed Thanksgiving as a national holiday, and we've been observing it ever since.

Thanksgiving is not just "Turkey Day." Neither is it simply a day of feasting. It is a day to THANK GOD FOR AMERICA! America is blessed with such an abundance that we sometimes tend to take the most important things for granted.

Americans should be thankful. We should thank our God that we and our children have homes, enough to eat, and warm clothing in the winter. We also have Christ and his covenant. We have a rich heritage, and a challenge to preserve it for our posterity. We also have the promise of a glorious future. Americans have a ministry to the world: a work of eternal importance. We have the freedom and liberty of the Spirit of Christ. We have a God who is with us always, "even to the end of the age" (Matt. 28:20).

Thank God for good times, and for bad. Thank Him for blessings, and for curses. Thank God FOR ALL THINGS, for we are nourished by His blessings, and are corrected and healed by His curses. "He causes all things to work together for good to those who love Him and are called according to His purpose" (Rom. 8:28).

"WORLD COURT has no political jurisdiction in U.S.," says President Reagan. According to a White House statement, the United States will formally cease to recognize the authority of the World Court except in non-political cases (those concerning debts, international commerce, and mutually submitted legal questions). This appears to be a step in the right direction, for a change.

What brought on this surprising break from One-Worldism? It seems that Nicaragua filed suit in the World Court against the U.S. for supporting and directing anti-Sandinista forces in that nation. Rather than argue the case in the World Court, the U.S. administration simply quit the case entirely, claiming that the 15-judge court, a U.N. agency that sits at The Hague, is hostile to the United States. The Administration also cited the fact that the Soviet Union, Cuba, France, Italy, West Germany, and Spain had earlier refused the "compulsory jurisdiction" of the court as well. This was the first time that the U.S. had suspended the World Court's jurisdiction since we acceded to it in 1946.

This is one of the few correct decisions to come out of the Reagan Administration, and proves how easy it is for the U.S. to refuse to submit to international authority. When the right people pull the strings, things happen. Since Reagan has his foot in the door now, I wonder if he would consider going a bit further and make a similar decision to withdraw from and stop supporting The United Nations?

SURPLUS MINERALS: Apparently, the Reagan Administration is not worried about the possibility of our being in a protracted war in the near future. They just recently made the decision to sell off \$2.5 billion in "surplus minerals" of the type that would be

needed in a war. These minerals include beryllium, chromium, cobalt, germanium, graphite, mica, natural quartz crystal, tantalum and titanium.

Reagan is also acquiescing to pressure from leftists to alienate South Africa, who supplies the U.S. with some of these important metals. In fact, one of the main arguments that I've heard concerning United States relations with South Africa is that we can't afford to lose their friendship because they supply us with these important metals, without which our industries would be in trouble, especially during a war. It almost sounds like Reagan is selling off the stock, and closing down the mine. This move could be seen as: 1. A traitorous sellout; 2. A sign that war is not imminent; or 3. Evidence that we already have such vast amounts of these metals in storage that we can afford to sell off the "surplus," and sell out South Africa.



THE MAIN PURPOSE OF THE IRS is not collection of taxes. Their main purpose is collection of information. Millions of Americans are beginning to recognize that the IRS has become an American Gestapo.

Perhaps you have heard of their "Five Year Plan." According to reports, the IRS has begun a plan of the type that we would expect from Russia: to organize a file on every taxpayer in the United States to include all the public and private information that they can get. Every business transaction, every license, even voter registrations will be kept in their computers for reference. The majority of their collected information will have no lawful bearing on taxes. For what purpose, then, are they collecting all this information?

To facilitate this huge build-up of information, the IRS had to install many more computers. Even at that, they still fell behind schedule in processing this year's tax forms, due to all the extra information that was being added to everyone's file. This information apparently is gathered from every agency you can

think of, and will now be readily on tap for "law enforcement" to use as a tool of prosecution (or persecution). In other words, they will have hundreds of pages of information on file on everyone in the country. This proves what we've been saying for a long time: The IRS is an agency designed to control the public, not simply to collect revenue. Big Brother is watching you!

MORTGAGE PAYMENTS getting you down? My advice is to avoid debt in the first place. However, for those of you who are already in the trap, here are some facts that may help you get out from under, sooner.

Few home buyers realize that a \$50,000 mortgage financed at 13% for 30 years will require \$150,000 in payments to be fully paid. In other words, you must buy the equivalent of three houses in order to purchase only one through the usury system. The first monthly payment on such a contract would be \$553.10, of which \$541.67 would go for interest. Only \$11.53 would apply to the principal on that first installment. The amount that goes to the principal will increase gradually with each payment, but for several years the interest payment remains considerably larger than the principal payment.

To reduce the number of payments, and thus the number of years you must pay on such a mortgage, you can simply send in an extra principle payment with each regular payment. In other words, using the above example, the first payment would apply \$11.53 to the principle. Send in an extra \$11.56 and you have just lowered the principle the same amount as if you had waited and sent in another \$553 payment next month. In other words, one extra month's payment was extinguished with only an extra \$11.56 paid at the time of the first payment: a practical savings of over \$540. Keep this payment plan up for 15 years, and your mortgage will be paid off and you will have saved \$74,424.25.

Another interesting plan calls for making biweekly payments instead of monthly payments. This plan is called a "yuppie" mortgage (don't ask me where the name came from). For example, the 30-year loan could be paid off in 19 years by simply making biweekly payments of \$276.55, instead of monthly payments of \$553.10. I'd venture to guess that not one home buyer in a thousand is aware of these facts. You can see how banking is designed to steal your labor and wealth. If you're not in debt, stay that way. If you are in debt, do whatever you can to get out of debt as soon as possible.

KEN ANDERSON was convicted of "practicing medicine without a license, fraudulent schemes and artifices, and conspiracy" a year ago last June. He served one year in jail, and is now out on probation. However, he filed an appeal with the Arizona Court of Appeals, hoping to be absolved of the crimes, since he and most of us who were familiar with the case knew that he was innocent of the charges.

In the first week of October, I got word that they had also rejected his appeal. This came as a blow to Ken and his family. They had hoped for a fair trial from the Court of Appeals. That hope was obviously in vain. It looks like he is stuck with the convictions and his present status of probation. He is out of jail, but must be under probation for another 6 years.

Having been a close observer of this whole case, I must admit that any hope of receiving justice through the courts now seems distant to me. Our Lord Jesus, when brought to court before the State, stood silent. I had often wondered why Jesus didn't at least speak out in His own defense. I think I now understand. When one is hated by the State, one cannot get fair treatment in state courts. In fact, if one does not have several hundred thousand dollars to pay for legal fees, he can't even pursue after this elusive thing called "justice." Justice is for sale in America, and only the rich can afford it.

"ORIGINAL INTENT." The Supreme Court is the last word on law in America. Their decisions are final. Deciding the intent and application of the U.S. Constitution is their dominion. One of the reasons that justice has become an endangered species in today's courts is apparent in a recent statement by U.S. Supreme Court Justice William Brennan. His statement, as reported by UPI, exposes and brands him as an enemy to our Republic and the American Spirit.

"The idea that the Constitution should be viewed as it was written nearly 200 years ago is arrogant, and turns a blind eye to social progress," he said. He added that to seek to discover and abide by 'the original intent' is merely "arrogance cloaked as humility. It is arrogant to pretned that from our vantage, we can guage accurately the intent of the framers on application of principle to specific, contemporary questions."

If Brennan has no use for the original intent of our forefathers who framed the Constitution, then he obviously has no use for the Constitution at all. In other words, he would decide issues according to

"current problems, and current needs." His view of law, and good and evil, is curiously similar to the view that was advocated by a certain "sly and cunning" humanistic teacher in Genesis 3:4-5, who said that men can make their own laws and be their own gods.

Justice Brennan said the historical record of the intent of the framers of the Constitution is not clear and that those who call for original intent "have no familiarity with the historical record." He also volunteered his view in opposition to the death penalty. He says he is opposed to it, and that it is "cruel and unusual punishment." I would assume that this official in high position (Eph. 6:12) is also opposed to our God who commands the death penalty for capital crimes. With such "spiritual wickedness in high places," no wonder our common people are downtrodden and without protection in the courts.

po we have a "Nobility" in America? Have you ever noticed how hard it is for a common citizen to prosecute anyone in government for wrong doing? Since we have lost access to lawful, functional Grand Juries, we usually can't even get a case started. In cases where a citizen, or a group of citizens, is lucky enough to actually get some government official into court, the resultant "trial" is usually so obviously prejudiced in favor of the government official that the people are simply discouraged from any further attempts to bring government criminals to justice.

Our Constitution states, "No Title of Nobility shall be granted by the United States." The English Nobility, against whom this law was formed, enjoyed superiority and privileged status over the common people. As you can imagine, it was near impossible for a Commoner to successfully prosecute someone from "the Nobility" in English courts. In other words, the Nobility was more or less judgement proof in terms of offenses against the common citizens. So, our Founding Fathers stated, in the Declaration of Independence, that "All men are created equal;" and thus deserve equal justice in the courts.

Well, it looks like we have the same problem again. Government officials have become "the Nobility" of our day, and are almost immune to prosecution by citizens. One bureaucrat will prosecute the other, and The State will prosecute a bureaucrat once in a while, but citizens cannot successfully prosecute bureaucrats. Those in government today consider themselves all on one side of a war, and the public on the other side. Therefore, in the face of enemy (public) accusations, the bureaucrats stick together, making

an insurmountable wall between themselves and the public. And since the public has been brainwashed to "not take the law into their own hands" (which is where it rightly belongs according to Common Law), all judgment and enforcement is in the hands of the bureaucrats and they are not about to bring judgment against themselves. Thus, we see a new "nobility" in America: THE BUREAUCRACY. These elite are indeed a privileged caste (but not very noble).



"HOLIDAY SEASON" is upon us again. With the pagan festivals of Halloween, and Christmas, one gets a little reluctant to go out into the public for fear of being assaulted by kids dressed as witches and demons, or by red clad, fat, bearded men in the shopping malls. Halloween (formerly called Samhain), and Christmas (Winter Solstice) are both heathen holidays, and are offensive to true Christianity. Did you know-

HERE'S THE PROOF! You've no doubt heard many hair-raising stories about the Jewish Talmud. Some of the tales are so strange that you may question whether they are actually true. Well, you don't have to wonder any more. I just found out that the complete English version of the Jewish Talmud is available for purchase from Omni Publications, Box 216, Hawthorne, CA 90251. Now you can prove it "right from the horse's mouth" (or perhaps it's the other end of the horse?).

The Talmud is admittedly the basis of Judaism, and the training manual for Rabbis. It was written by Rabbis to train Rabbis. People who have never read any of these demented writings of dirty old men can't imagine the filth in which Judaism is immersed. Do you have any fundamentalist, Judeo/Christian friends who insist that Christianity was spawned from Judaism? "MISHNAH. He who gives of his seed to Molech incurs no punishment unless he delivers it to Molech and caused it to pass through the fire. If he gave it to Molech but did not cause it to pass through the fire, or the reverse, he incurs no penalty, unless he does both." (You can give your child to Molech, or you can burn him in the fire, but you can't do both).

Another related quote:

"R. Aha the son of Raba said: If one caused all his seed to pass through (the fire) to Molech, he is exempt from punishment, because it is written, OF THY SEED, but not all thy seed." (This implies that it is OK to


sacrifice ALL of your children to Molech as long as you don't keep any of them back).

Other statements are too vile to quote here. You may also notice that Talmudic writings are somewhat similar to modern-day law books: worded vaguely so as to allow any interpretation that is needed for the occasion. Yes, the priestly, black-robed Masonic judges of our modern courts are presiding over a system that is possessed by the Babylonian Talmudic mentality.


David Goldstein said that anti-Semitism in the

An article from the Sept. 29 issue of the "Des Moines Register" interviewed Joan Blundall, "a mental health clinician who works with farm families" (suggesting that it is the farmers who are crazy, instead of the bankers). Blundall said, "There is such anger out there. It's not something we're going to be able to stop - we'll only be able to pick up the pieces."

It seems that the recent segment on ABCTV's "20-20" program titled "SEEDS OF HATE," was a "call to arms" for the Jews against the farmers. Apparently, whereas up until now they have vented their hate mostly in the direction of "anti-Semitic" (sic) churches, now they are also turning and attacking the farmers. EASY ANSWERS for America's terrible money problems seem to go unheeded. Congress would have us think that the deficit budget, and the national debt are problems that are so COMPLICATED that even the best minds are unable to help.

Margaret Thoren, author of FIGURING OUT THE FED, recently suggested a simple solution to a large part of the problem. She suggested that Congress take a close look at the Federal Reserve System for clues to success. The FED has operated for the last 70 years as America's central bank, without getting into debt. During that same time, Congress has gone over \$2 trillion into debt. Perhaps Congress could learn from the FED how to stay out of debt.

For one thing, the FED creates and issues its money, whereas Congress always borrows and pays interest on its money. The Treasury and Congress stay in debt by borrowing from the FED: an agency the Congress created. The people of the United States must then be taxed more and more to pay the debt, and the usury on that debt, created by the stupidity of Congress.

If Congress was half as prudent as those who control the FED, Congress would create its own money, directly from the U.S. Treasury, and stop borrowing it at interest. Congress can create their paper money, debt-free and interest-free, the same way they create their coins.

They could create and spend into circulation enough money for their annual budget, and then tax that same amount back out of circulation that year. That would finance the whole budget without a deficit, without usury, without a rollover of the debt, without inflation or deflation, and without a national debt. But then, this answer is probably too simple for the complicated brains in Washington D.C.

NEW EQUIPMENT: Our old Compugraphic Typesetter is finally being replaced. We are awaiting delivery on our almost-new Linotype laser typesetter that is compatible with our Zenith computer. The capabilities of this machine will enable us to do much more than before - with better quality.

With the old machine we were suffering several breakdowns during the production of a newsletter. It had gotten to the point that we just expected trouble

every time. After checking around for replacements, and their prices, I feel we were fortunate to find a one-year-old machine, refurbished to factory specs, and with a new machine warranty, at about half what it cost new. New, it cost over \$20,000.00. We got it for a little under \$11,000.00.

While this was a real bargain by the standards of other typesetting businesses I talked to, it represents a large outlay of funds for us. We are also in bad need of a replacement for our old stitcher-folder machine. I understand they are even more expensive than typesetters. As God always provides us with the means to buy what he wants us to have, without going into debt, I place these needs before you, our readers, for you to pray about with us, and give as the Lord leads you.

Your generosity in the past is bearing fruit today. Your past support of this ministry has enabled us to buy equipment, radio time, and facilities, resulting in much information going out from here. The current revival that is happening here in America is partly due to your support and efforts through this ministry. Your investment is paying off, and Jesus is glorified. There is more information about Christ's Kingdom being circulated today than ever before, because of our combined efforts. Let's keep the pressure on!
